

New York State Licensing Regulations for Child Care Centers

Updated 5/2016

I. SUPERVISION OF CHILDREN

- Each child enrolled in a child care center must be at least six (6) weeks old.
- All children must have a physician's medical report and be current on immunizations to participate in child care.

• The following adult/child rations must be adhered to:

- No child can be released from the childcare center to any person other than his or her parent, a person designated in writing by the parent, or a person authorized by law to take custody of the child.
- Children cannot be left without competent direct supervision at all times.
- Surveillance cameras may not be used as a substitute for direct supervision of children.

II. DISCIPLINE

• The childcare center must have written disciplinary guidelines and provide copies of these to all staff and parents of the children in the child care center.

- Corporal punishment is prohibited. Isolating a child where he or she cannot be seen and supervised by a staff member is prohibited.
- Withholding or using food, rest or sleep as punishment is prohibited.

III. SANITATION/SAFETY

- All rooms, equipment, surfaces, supplies, and furnishings accessible to children must be cleaned and disinfected as needed to protect the health of the children.
- There must be adequate and safe water and sewage and a constant supply of hot water.
- The childcare center must have a first aid kit, emergency procedures, a health care plan and policies and procedures for the health and wellbeing of all the children.
- Emergency drills must be conducted monthly.
- Toilet facilities must be kept cleaned at all times, and must be supplied with toilet paper, soap, and disposable towels accessible to children.
- Individual drinking cups, disposable paper cups, or bubbler drinking fountains must be provided. The use of shared drinking cups is prohibited.

IV. NUTRITION

- The child care center must provide plentiful and nutritious snacks to children.
- The center must ensure each child in care for more than four hours receives a nutritious meal.
- If the childcare center does not furnish meals, there must be supplemental food available in the event that a parent furnished no meal or if the meal is of inadequate nutritional value.
- Centers changing their meal policy must provide adequate notice to parents.
- Where formula is required, it may be prepared and provided by the parent, or by a qualified, designated staff person when agreed in writing by the parent.
- Each infant or toddler must be removed from the crib, playpen, or cot and held or placed in an appropriate chair for feeding.
- Infants 6 months or younger must be held while being bottle-fed. The propping of bottles is prohibited.
