Believe it or not, the spring programs are winding down and we have started planning for the summer programs.

We are excited to once again host the Summer Youth Employment Program. We have a number of opportunities available in house and also partner with the Broome County Humane Society and Greater Good grocery store to offer a variety of employment opportunities.. Over the summer months we continue to provide Early Head Start programming and several Head Start and integrated preschool classes.

We continue our pursuit of housing opportunities as they present themselves. Our Robinson Street site is full and we have another HHAP project in the development. and are also working with the City of Binghamton to identify affordable housing opportunities.

We are in the process of purchasing a building on Washington Ave in Binghamton. This will be used to relocate our classrooms from Saratoga and Carlisle apartments, and allow for additional agency wide program development.

While we continue to write grants and look for program development that meets our community assessment needs. We recognize the need to spend time developing and assimilating those programs into what we do.

We continue to upgrade our technology as funds present themselves. We have a technology replacement plan so we continue to search for funds to accomplish this. One of our biggest challenges is remains finding staff for the multitude of positions we have available. Hopefully this will turn around in the near future.

All of this makes for a very busy and exciting summer. Even though we continue to grow and expand, providing high quality services is our number one priority. We must continue to grow but also continue to maintain our high level of quality the community and families expect.

Head Start

Family Enrichment Network Offers Families a Free Summer Food Program

For the past fifteen years, Family Enrichment Network has hosted a summer food services program. In the early years we provided a morning snack and lunch program, in the past five years we have offered breakfast and lunch. We are an open site, so all interested children and their families are able to participate in our program daily.

Hunger is a local, state-wide, and national challenge that our families deal with on a daily basis, and providing these services allows families to better stretch their food dollars; offers them an opportunity to eat as a family; and provides them with nutrition and healthy meal ideas that they can prepare for their children at home.

The Food and Nutrition Services, USDA Summer Food Services Program assists families in obtaining **FREE** nutritious meals and snacks for their children when school is out.

The program runs from July 5, 2023 through August 18, 2023. Breakfast will be served from 8:00 a.m. to 8:30 a.m. and lunch will be served from 11:30 a.m. to 12:30 p.m. Monday through Friday each week at Family Enrichment Network in the Cafeteria.

Parents attending our program with their children will be invited to enjoy a free meal, too. The adult meals are paid for through local contributions secured specifically for these adult meals.

Childcare is expensive!

Department Spotlight

Housing

The Housing Department was formerly the Housing and Community Services Department, but separated in 2022 in order to better focus on our growing housing programs.

Family Enrichment Network has received ESG (Emergency Solutions Grant) Funding from the city of Binghamton for over ten years to offer homeless prevention programming, known as the Caring Homes program. The Caring Homes program serves individuals and families at-risk of becoming homeless due to rent arrears and/or utility shutoffs as a result of a hardship. With the ESG funding, we are able to provide a security deposit or rent arrears for those who are homeless or facing homelessness, as well as utility arrears for those who have a current shut off notice. Participants must reside in the city of Binghamton, NY to receive assistance. In 2021, we provided financial assistance to 89 families while in 2022 we provided financial assistance to 162 families. This clearly demonstrates the need for financial assistance two years after the pandemic.

COVID-19 impacted all of us throughout 2020-2022. New York State has recognized the financial hardship this has caused and has allocated ESG- COVID funds to our region to financially support families. The funds allow us to offer additional homeless assistance and homelessness prevention activities. Available funds may be used for rental assistance, security deposits and utility shut offs. Participants must reside in the city of Binghamton and have been directly impacted by COVID-19 to receive assistance.

In March 2021, we opened the doors to our first homeless housing project, Housing Connections. Housing Connections provides 19 supportive housing units, comprised of four one-bedroom apartments, ten two-bedroom apartments, four three-bedroom apartments, and one four-bedroom apartment. The program prioritizes homeless youth ages 18-25 years old; formerly incarcerated (non-violent offenders); survivors of domestic violence; individuals with a substance abuse disorder; people with an intellectual or developmental disability; chronically homeless; and disabled military veterans who have an unmet housing need. Supportive services include: rental assistance, trauma informed assessments and case management, adult literacy, parent education, child care, job readiness training, digital literacy training, financial literacy, housing education, referrals to substance abuse and mental health counseling, benefit advocacy, life skills training, and transportation.

Since opening, we have housed 28 families. In 2022 we started offering classes to our families and opened it up to the community. We offer Healthy Relationships, Anger Management and Parenting. The classes have been well attended and we plan to offer them as long as people continue to show up.

Although we provide support and assistance we also recognize the need for specialized services. Each family is unique in their needs and it is important that we recognize this and meet the family where they are at. Wrap-around services and referrals are an important part of a tenant's success. We have developed and fostered relationship with agencies such as Prime Care Coordination, CPS, CHOW, Lee Barta Center, Catholic Charities Diaper Bank (through Jessica's Corner), Baby Book Buddies, Mothers and Babies, Office of Veteran Affairs, Weis, Planned Parenthood, Phil Financial Group, Rise Shelter, and the New Hope Center, just to name a few. This is a snapshot of agencies that we collaborate with.

In addition to Housing Connections, we own five properties in Binghamton and Johnson City that we rent to individuals and families. We own two properties located on Roberts Street (11 Roberts St., and 51 Roberts St.), a single family home located at 241 St. Charles St., a two unit home located at 11 Crocker Ave and a five unit building located at 146 Robinson St. All of the homes are Section 8 certified.
