From the Desk of the Executive Director

Spring is just around the corner. For some reason, it felt like a very cold and long winter and we welcome the change in seasons. The Network continues to prepare for the future even in an era of uncertainty. No matter what happens at the government level, there will be people that need assistance and we will figure out a way to make that happen. This is typically a busy time of year, and this year is no different.

The big item continues to be the covid virus and how it impacts our staff, children, and families. There is light at the end of the tunnel with the vaccine. In the meantime, we need to remain vigilant with wearing face masks and social distancing. We encourage all staff and parents to get vaccinated as soon as they become eligible. The sooner we vaccinate, the sooner we get back to normal.

Our big addition is our 19 unit housing project for the homeless, with another state grant, ESSHI, to provide supportive services for those living there. Construction is complete and we will start moving in people in the very near future. We will continue to look at additional housing opportunities as they arise.

We are also in the process of providing transitional housing to people upon release from being incarcerated. They need a safe place to go until they can make long term living arrangements; otherwise they struggle and end up re-incarcerated. If this works out, we will begin looking at providing longer term housing to meet these needs.

We have completed our move to a \$12.50 minimum wage for all staff. With existing

funding sources, this continues to be a challenge.

We could not do so much that without the support of the staff, the Governing Board and the entire community. Our staff this past year has worked tirelessly to assist us in moving this agency forward and to meet the needs of children and families. We thank you for your past support of our Agency and look forward to future partnership opportunities. We look forward to another productive and prosperous year.

Housing and Community Services

The Housing Connections project is COMPLETE!



On February 24th Family Enrichment Network celebrated the completion of the “Housing Connections” project with a ribbon cutting ceremony hosted by Mayor Rich David. The project is located at 29 Virgil St. in Binghamton NY. **“Housing Connections”** will provide 19 permanent supportive housing units ranging from one bedroom to four bedrooms. The apartments are fully furnished and come with onsite laundry. The building has a community room that will be available to tenants for workshops and educational classes. In addition, the community room will be available to community members to access for events, by reservation only.

To qualify for housing the individual/family must be homeless and income eligible. The focus will be young families and individuals ages 18-25; individuals with developmental disabilities; domestic violence survivors; veterans; chronically homeless; and formerly incarcerated individuals. The agency's goal is to help end homelessness in the community by providing safe, affordable and quality housing. Case management and life skills support will be provided to meet the individual needs of the tenants. Referrals for housing will go through 211/First Call for Help. We are excited to open our doors.
