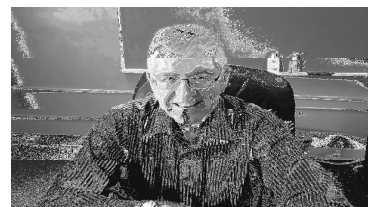

Cheaper results in poor quality, high staff turnover, and the number of people in general who want to work in child care decreases. The number of child care centers in the area that have closed or had significant issues this past year is alarming. There are still more centers that are on the brink of closing in the near future. The long-term answer continues to be a cooperative effort between government, not for profits, and the business community.

We thank you for your past support of our Agency and look forward to future partnership opportunities.

Child Care Resource and Referral awarded continuation of national accreditation validation! Family Enrichment Network submitted the 5th annual Quality Assurance validation renewal in September 2017. The Child Care Resource and Referral department held the annual Chenango County Fall Conference in Norwich on Saturday, November 4th. The theme of the day was "Going Above and Beyond" and had a variety of workshops to encourage providers to rise above and provide the highest quality child care for their children.

Morning workshops included how children learn through play, PBS materials, and the OCFS licensing regulations. The afternoon group workshop was focused on the Pyramid Model and ways to support young children's social and emotional development to prevent challenging behaviors.

Playing Outside in Cold Weather Keeps Children Healthier.

It is not true that being exposed to cold weather causes people to get sick. People get sick by being exposed to bacteria and viruses that are shared indoors. Taking the children outside to play removes them from their germ environment.

Outdoor play motivates children to move their arms and legs more effectively to exercise them. When they are moving a lot and quickly, they will stay warm and get the exercise they need to stay healthy. Moving through snow helps to strengthen muscles and improve gross motor development. Encouraging children in outdoor activities helps them to sleep better and maintain healthy weights.

Children's imaginations are stimulated to create different activities to stay occupied when the playground equipment is unavailable for use. Teachers can teach children how to make snow balls and snow men, food coloring can be added to the snow so that children can see how colors mix together to make new colors. They also learn how to identify and avoid slippery areas so that they learn how to safely walk in the winter time.



Being outside exposes children to Vitamin D, which is vital in forming strong bones and essential in preventing depression.

Family Enrichment Network follows the "Child Care Weather Watch" chart that identifies safe temperatures to be outside. It was developed by the Iowa Department of Public Health, Healthy Child Care Iowa, through federal grant funds from the US Department of Health & Human Services, Health Resources & Services Administration, and Maternal & Child Health Bureau. Wind-Chill and Heat Index information is from the National Weather Service. The chart is endorsed by Head Start as a reliable source for determining when children should play outside. Many sources on children playing outside state that a child should be outside in winter, but for temperatures under 32° F, outside time should be limited to 20-30 minutes. This is a policy that we will be adopting this winter at Family Enrichment Network. Parents are urged to dress their children in winter time to be prepared to be outside for at least a short period of time to promote their health. Donations of coats, hats, mittens, boots and snow pants are welcomed to keep on hand for those children who need them.

What's New in Community Services???

Waiver Services!

Important Points:

- Waiver services are Medicaid funded programs developed to meet specific needs of individuals with Developmental and Intellectual Disabilities.
- Individuals must be granted eligibility for OPWDD Waiver services by completing the "Front Door" eligibility process.
- Waiver Services are Person Centered and tailored to the specific needs of the individual and family.
- FEN offers agency supported self-directed services and direct provider purchased services.

FEN is Now Offering Respite and Community Habilitation Waiver Services for Individuals with Developmental and Intellectual Disabilities.

Respite Services are designed to provide family members and caregivers relief from caregiving. This service is an important resource to support families in continuing to care for their loved ones at home. Respite is only available for individuals who live with a caregiver in a non-certified, community setting.

Respite services are available during the day, evening, overnight and weekend hours.

Families may hire their own staff who can then become employed by FEN to provide the service to their loved one OR families may choose to interview and select staff currently working in the program. Self-hired staff must meet all the employment requirements of FEN and pass a background check.

The number of service hours is based on the need of the family.

Community Habilitation services are developed to assist individuals in gaining independence in different areas of life, such as budgeting, activities of daily living, and many other areas the person feels they would like support in. This service is also based on Person Centered Planning and can encompass any goal the individual feels they would benefit from. Community Habilitation uses the platform of community integration and exploration to assist individuals in working on and meeting their goals. Most of this service will take place in the community, allowing the individual to become integrated into their community and build relationships with the support of a Direct Support Professional (DSP).

Individuals living in the community, on their own or with loved ones, as well as individuals residing in certified residential settings are eligible to receive Community Habilitation.

The number of services hours per week is based on the need of the individual and can range from 3 to 25+ hours of service per week.
