As we enter the spring season it continues to be an exciting time at the Agency. We have completed our move to a \$13.20 minimum wage and beyond for all staff, however with existing funding sources this continues to be a challenge. We continue to navigate the coronavirus and how it impacts our staff, children, and families. There is light at the end of the tunnel even with recent uptick in cases. In the meantime we need to remain vigilant. We still encourage all staff and parents to get vaccinated.

Despite many uncertainties, we are pleased to report that the government has made a commitment to increasing the availability of child care. Governor Hochul recently announced \$70 million in federal funding to address child care deserts. Funding will support new child care programs in areas without sufficient child care slots. The area that provides continued growth is housing. Two years ago we had just six units, we now have 31. We just submitted another letter of intent for ten additional units of HHAP homeless housing. We have also had interest from Chenango County for homeless housing. The need is there. We have several more opportunities in the works. We are also in the process of trying to provide transitional housing to people upon release from being incarcerated. There needs to be a safe place to go until they can make long term living

arrangements, otherwise they struggle and end up re-incarcerated.

The Agency continues to have a very aggressive development program, to include program development and expansion in general. We have been blessed with very supportive community partners with foundations and government agencies being very supportive. If there is something we are doing well, tell us. If there is something we could do different or better tell us. Our sole purpose here is to meet your needs and community needs.

II Crocker Ave in Johnson City is a two unit home. The home contains one one-bedroom bedroom unit and one two-bedroom unit. The home is Section 8 certified.



146 Robinson St is a five unit building. It contains one one-bedroom unit and four two-bedroom units. The home is Section 8 certified.



Lack of affordable and quality housing in our area is at a critical level. Homes and buildings are being condemned while landlords are converting units to student housing. With the current uptick in evictions the housing crisis is more apparent than ever. Family Enrichment Network is committed to helping close the gap on homelessness and will remain dedicated to supporting those most in need.

## **Department Spotlight**

#### **Family Support Services**

The Family Support Services (FSS) Department started 17 years ago (2006) due to the number of special projects that were no longer specifically childcare or child development related. These projects were developed in response to gaps in services identified through our annual FEN community assessments. Over the past 17 years, FSS has offered 11 distinct programs each with different funding sources, rules and regulations. Depending on the specific program, services were offered in one or two of the following counties: Broome, Cortland, Delaware, and/or Tioga.

Our FSS programs fill important needs in people's lives and really make a difference for individuals and families of all kinds. Over the years the FSS department has helped survivors of domestic violence achieve independence, helped individuals with disabilities find employment, helped working families purchase cars, assisted families in signing up for WIC and SNAP benefits, provided a NYS certified parenting class to help court-ordered parents manage custody and visitation issues while minimizing the drama in their children's lives. We also offered three programs for formerly incarcerated populations: a support group for formerly incarcerated mothers that focused on family reunification and improved mother/child relationships; another group for unemployed and underemployed individuals with criminal records that focused on employment resources and training; and a parenting class in the women's pod at the Broome County Jail.

Currently the FSS Department is responsible for three programs: Kinship Care, Walk With Me, and the Courthouse Children's Center.

The <u>Kinship Care</u> program provides support and advocacy for kinship caregivers (adults raising someone else's child/ren) in Broome and Tioga Counties. Kinship program services are provided regardless of a caregiver's income and include assistance navigating the Department of Social Services, Family Court, school enrollments, referrals, community resources, and a weekly support group. The program also provides up to date information on kinship care laws and regulations. For more information please contact Julie Morgan at ext. 840.

Walk With Me (WWM) is a reentry program that helps individuals resettle back into the community after being released from the Broome County Jail. WWM provides personalized advocacy and support to each program participant, assisting with any barriers or challenges that may arise. Housing, employment, establishing benefits and transportation are all addressed by the program, as well as assistance obtaining, clothes, hygiene items, furniture and household items as needed. Through WWM's partnership with Justice and Unity for the Southern Tier (JUST) we offer support groups and peer mentoring. For more information on WWM please contact Chamisse Morast at ext. 1675.

The Courthouse Children's Center provides free drop-in childcare for any adult with business in the Broome County Family Court. Unfortunately, the Center is currently closed at the request of Family Court due to restrictions from COVID and the reduced in-person court calendar. However, for 19 years the Center has provided a safe, fun, and educational haven for children, away from the tensions and stress of the Family Court waiting rooms.

## **Employee Spotlights**

#### **Chamisse Morast**

I started my journey at Family Enrichment Network Work in July of 2021 as a volunteer in the Reentry Program, Family Support Services Department. My passion for helping people has always led me to jobs where I could give back to the community. When I was offered a position as a Reentry Specialist in September 2021 I gladly accepted. I was previously employed by the Volunteers of America here in Binghamton. While working there I realized I wanted to do more to help to formerly incarcerated people. I am originally from Brooklyn, NY and moved to Broome County in 2011. Since then, along with my sister, I started an organization called "Surviving Ladies" and we donated over 200 book bags to children in the community in August of last year. I hope to continue to be a positive reinforcement for the community.



#### William Wrighter

Bill is new to our staff, starting in July of 2021. He is not new to Family Enrichment though. He attended the school when he was a youngster then again under the summer youth program in 2017 and 2020. After graduating from Johnson City High School he attended BCC. He came to me last May wondering if we had any positions available, and remembering his excellent work ethic, I hired him immediately.

As a summer youth member, he has done everything from cleaning the building, playground renovations at Cherry St. and Fayette, and some construction at different sights. He has worked at all the locations except for Norwich and is familiar with both cleaning and some operations. Bill is still working on his driver's license and does all the driving for us older folk. His plan is to have his license by May 1st.
